[[Pursuant to rule 22 the Companies (Incorporation) Rules, 2014]

1. Notice is hereby given that in pursuance of sub-section (4)(ii) of section 8 of the Companies Act, 2013, an application has been made by JCB Literature Foundation to the Registrar of companies, Delhi & Haryana at Delhi for revocation of the licence issued to it under section 8(5) of the companies Act, 2013. After the cancellation of license, the company will be required to add the word "Private Limited" to its name in place of "Foundation".

2. The principal objects of the company after the revocation of license as per the provisions u/s 8(4)(ii) of the companies Act, 2013 shall be as follows:

- i. To implement work in the area of preservation and promotion of literature, literary awareness and study of literature among the common masses of India, by way of establishing awards or prizes, constructing library, sponsorship programs, whether by itself or in co-operation and/or association with any other trust, company, fund, non-profit company and such other institutions in furtherance of the object
- ii. To promote, undertake, plan, organise, develop and execute activities that would support, encourage and promote new writers, authors or translators of various Indian/ Foreign languages, through funding or mentorship or sponsorship or any other supporting programs and projects, aligned with the core objective of promotion of literature
- iii. To organise such programs, events, workshops, seminar, lectures, conferences and symposiums in India to provide platform to the prospective and leading authors and academicians and to provide monetary support to students for attending such programs and events of the prospective or established authors.
